Have you recuperated from our very busy Season of Service? Starting with our Thanksgiving lunch at Washington Elementary, three days of eye and hearing screenings at Washington, Roosevelt, and Ogden Elementary Schools, two days of Salvation Army Bell Ringing, and the Santa Store and its associated weather related challenges, we were energetically engaged this past two months. More can be found on these activities as you read on through this newsletter.

We had a service activity both spontaneous and new this year. Lions Chriss Denny, Nancy Brown, Gay Enyeart, and Lion spouses Linda Licata and Bernadette Shalaby were led by Lions Eva Halter and Jen Leger in a fundraising activity to help foster children. The team produced around two hundred hand-crafted college and NFL themed stuffed sock snowman that they subsequently sold at the Legacy Hospital annual Christmas fair. Their efforts raised \$1000 for Bridge the Gap, a community outreach program designed to enrich the lives of abused and neglected children in Clark and Skamania Counties. mental project at the Fort Vancouver National Historic site as an MLK Day of Service. In March we are planning to hold our Habitat For Humanity build day under Lion Bruce Armstrong's direction. And I've asked Lion Stephen Staudinger to form a Melvin Jones Award committee for the club.

Our FVLC Board of Directors has been in discussion for a while to help us better understand how to put our foundation resources to work in a reasonable time frame. Over the past several years, our foundation has benefited from a few windfall donations. In parallel, a series of FTVC Lions Boards in good faith have done what so many people do in similar situations; that is balk at tapping into an accrued surplus no matter its amount or age. consequence of this is that our foundation balance becomes static in a way that was never intended by our benefactors or ourselves. So we decided to put some collaborative thought into what a good reserve guideline should be and how to encourage ourselves and future boards to meet the expectations of our donors and put the money to work for the community in accordance with our mission in a timely way. I will be sharing more about this with members at our general membership meetings in January. We expect to vote on this new guideline at our January 20 board meeting.

In closing this month's presidential message, I want to again ask everyone to focus on FVLC membership growth and sustainability. As we know in the end, everything we do depends upon membership. We need to find ways to recruit new members from all segments of our community. The membership need is great in order to insure our future. We need ideas and actions on this to abound

#### Fort Vancouver Lions Board Meeting November 17, 2016 Minutes

The meeting was called to order by president, Tony Licata at 4:30 AM. A quorum was established. Members present were Tony Licata, Doug Wilson, Gay Enyeart, Len Leger, Chriss Denny, Eva Halter, Wanda Slevin, Martha Johnson, Steve Staudinger, Craig Limoges, and Lee Denny. Guest Lions: Tracy Fortmann, Delores Milligan, Ken Milligan, Bill Shallaby, Helen Sutfin, and Terry Sutfin.

**Minutes:** The minutes from October 14 were approved unanimously.

**Correspondence:** No correspondence.

**Treasurers Report:** Gay reported on the Administration (Club) and Foundation accounts. Currently, the Club account has a total of \$32,140 and the Foundation Account has a total of \$27,057. She reported that two checks from the MODA center work was recently deposited to the foundation account totaling \$900. Tony noted that the money raised from the MODA center project had to be deposited into the 501C3 Foundation account. Tips can go to the administration account. Gay reported that recently \$98.50 in tips from the MODA work had been transferred into the administration account.

Proposal Title: Approval of FTVC Lions Membership New Lion Barbara Fey

**Proposal Description:** Lions Delores and Ken Milligan have introduced new member Barbara Fey to the Fort Vancouver Lions. Lion Delores is acting as Barbara's mentor. Barbara has visited our club meetings on a number of occasions, has attended an orientation meeting with Lion Craig Limoges, and submitted her completed LCI membership application and FTVC Lions annual dues payment. Additionally she is already volunteering for club service projects. This is a proposal for the Board to formally to approve Barbara's membership and welcome her to the Fort Vancouver Lions.

FTVC Lion Board Member Making Motion for Consideration: Martha FTVC Lion Seconding Motion: Steve

**Describe Motion:** Motion approved unanimously

Committee Report: Fort Vancouver Lions Reserves Committee Committee Members: Doug Wilson, Len Leger, Lee Denny

**Doug** discussed the committees' work in drafting two budget proposals for reserves, one for the Club and one for the Foundation and a proposal for a grants committee. For the former, in short, a sum of 25% of the current year's budget would be reserved in case of performance shortfalls and to identify any surpluses in the accounts that could be used to benefit the community. Tony suggested that there is a need to spend our surplus. He suggested that the proposal was a simple solution that did not legislate to the board how to spend the surplus.

Steve was not comfortable with a three month buffer and prefers a six month buffer. He also suggested that the actual expenditure average over the last three years would be a better metric for determining the reserve. Craig suggested that the proposals, once they are finalized should go out to the membership via email, hard copies at meetings, and snail mail for those who do not have email. Delores commented that she wants to make sure that the sight and hearing committees and our commitment to diabetes work is covered. Len posited that the development of three years of actuals may be difficult. Craig reported that the topic had been the subject of past boards, including his, and he supported (in concept) the guidelines. He also noted that a very important Lions project may require going into the reserves in any given year. Also some projects may require movement of funds from the club to the foundation. The reserves policy will give us a guideline for how much can be moved or spent. Chriss noted that for a big project, the board would bring it to the general membership.

Tony noted that the club is trying to solve the issue of what to do with excess funds. Given that some of the donations were given with the expectation that they would be put to good work, we have an incentive to formulate a means to utilize these windfalls. If there is a good idea and the club is willing to invest, then we can move forward. Wanda argued that it was unnecessary to have reserve guidelines for the club account as much of this came in the form of dues. Craig noted that in the past when the surplus in the Admin fund went beyond immediate annual uses (associated with work at the amphitheater) it could be put to good use. Lee noted that in the past, the board budgets have transferred funds from the administration account to the foundation account.

It was decided to send the proposals back to the committee for review of the input from the board and club members and to return it to the board. From there, if it is acceptable to the board, it would go to the membership for input. After input from the membership, it would return to the board for approval.

Tony then read the proposal for a grant-making committee. He clarified the process as the annual budget would establish the usual groups we support with funds and any funds available in excess would be targeted for grants. A Grants Committee would send a letter to those groups in the past which we have given nominal amounts to and request proposals in the \$500 to \$1000 range. Tony indicated that the process would not replace proactive giving which will be covered in the annual budget. The process will allow for larger grants that can do much more good than the small nominal donations the club has done in the past. Steve suggests that the process should not be too

complex or time consuming. It was decided to send the proposal back to the committee for review of the input from the board and club members and to return it to the board with the reserves proposals.

**Formation of a Melvin Jones Banquet Committee.** Tony expressed the desire to form a Melvin Jones Banquet Committee. Steve volunteered to chair the committee.

**Centennial Project Ideas.** Tony identified a few possible project ideas for the Lions Centennial including financial support for an 80-ft. tall flagstaff on the parade ground of Fort Vancouver National Historic Site, a Project at Columbia Springs, a work day and/or other project for Habitat for Humanity. Martha identified a proposal for a Year of Hundreds: including:

Serving 100 meals at the Share House

Distributing 100 blankets and/or 100 turkeys and/or 100 books and/or 100 cans of food or loaves of bread to those in need, or

Other service projects that could have a metric that adds up to 100 to celebrate the Centennial.

Tony wishes to form a Centennial Projects Committee.

Craig noted that Cub Scout Pack 320 was requesting \$350 for its chartering fees, which should be taken up with the board next month.

Helen noted that at the President's Council, there was a need for a donation for the stands for Flags for First Graders. They are about \$2500 short this year and Helen indicated that a donation of \$250 would help out greatly.

The meeting was adjourned at 5:35 PM. The next board meeting will be at 10:30 on Friday, December 16 at China Cook Lounge prior to our Friday lunch meeting.

Ralph Harding reported on the status of endowments. The value of December 6, was \$46,973.73 and this is down \$ 465.09 since November 1, report.

Continuing Matter: Discussion of What to Do When Endowment Fund gets down to \$25.000. Discussion included: The \$25,000 is an important number because one benefactor of the cause of Lions Sight in Clark County gave the Committee \$25,000. Over the years there have been other private contributions in the amount of \$10,000 donated. In addition grants in the amount of \$10,000 and \$15,000 have been given by the Firstenberg Foundation. \$2,000 grant from Riverview Bank is pending.

One comment was that presentations to Lions Clubs in Clark County have been important in generating interest in sight services and related funding.

The Lions Sight Foundation of Clark County is a 501(c)3 organization and tax credits are earned by individuals who contribute to Lions Sight Foundation of Clark County, PO Box 1804, Vancouver, WA 98668 - 1804.

In recent years the Foundation has supplied examination and glasses annually from 370 to 400 individuals, plus 470 in 2008. The average cost per individual is near \$100 each. The fee we pay to service providers is \$ 25 for frames, \$ 50 for regular lenses, \$75 for bifocals. Exams are \$50, however most of clients receive free examinations through government or social service providers.

If LSFofCC provides 400 glasses in a year, expected revenues to cover expenses would be \$40,000. What would be the pro-rated cost per individual Lion in Clark County?

In the past, the Auctions netted \$10,000. Two individuals who did the heavy lifting on the projects are no longer involved in Lions Foundation efforts. The bulk of the funding for the auction, was provide by Lions members, who provided the items, bought the items auctions, and by their ticket purchase paid for the food and the rental of the facility.

Another source of additional funding, can come from contributors whose employers match employee giving to helping agencies.
