Fighting Hunger in Clark County

Ft. Vancouver Lions are serving the Vancouver community by working with the Clark County Food Bank to fight hunger. On Wednesday mornings we are harvesting produce from Heritage Farm, the 79 acers of the Washington State University Extension Campus. This site was formerly the Poor Farm established during the depression of the 1930s. On Sundays at 3pm we pick up the unsold produce from the Farmers market in Vancouver. These are two service opportunities that are managed by an AmeriCorp member, Cami, who is serving for nine months at the Clark County Food Bank.

This last week we harvested 500 pounds of onions and at least that many pounds of apples and 100 pounds of cucumbers. Volunteers Allen and Renee' Rhyasen, Jennifer Denny, Michelle Drushel, Sophie Doane and Eva Halter have spent time in the garden and transporting produce from the Farmer's Market to the food bank. Working in the garden is both therapeutic and peaceful hard work.

Everyone wears a mask so we are protecting the consumers of the produce harvested from any potential Covid-19 contamination.

The farm is expected to produce 190,000 pounds of food for our community.

What is a 'forwarder'? This person will receive emails that needed to be forwarded to various club officers. Usually, this is done by the Zone Chairman. To date we do not have a Zone Chair, so the flow of information from the Multi-District, District, Zone and Club leadership is not being sent. This is creating a void.

Job description: a list of all Lion leaders email addresses and up-dates will be given.

As notices are received from Zone leaders they will be sent to the 'forwarder' who in turn will forward them to Zone 2 club and leadership team. Time commitment - the messages to be sent along are not many - the end of the month would be the busiest with items from the Governor and Multi-district office. This is not a huge time requirement. It just requires someone who will take on the responsibility of moving the inter-district mail along.

Fort Vancouver Lions "Flash Frozen Berry" Sale

Changes, there are always changes!!

Our 2020 frozen fruit sale was very successful this year, in part because of the restrictions placed on us by COVID 19.

In June, our famous and biggest fundraiser "Fresh Strawberry" sale was cancelled as our grower (Columbia Fruit) could not provide fresh berries.

This left us with our "Frozen Berry Sale" which we approached differently because of the COVID 19 concerns and state rules.

We needed to cut costs so we decided not to mail out flyers and market solely by email and Facebook. This decision saved us approximately \$700.

Dotty approached Facebook differently than we had in the past to cut costs and refine our marketing. We spent \$160 on Facebook compared to previous years \$300.

The customers were able to download a paper order form from our website and mail in their check as in the past. About 25% of our customers did that.

"Online" orders were higher than ever.

Len Leger came up with this idea! With about 10 days left of the sale he recommended we make calls to past customers (fresh strawberry & frozen berries) who have not ordered this year. Wanda and Bill prepared a customer list of people who bought last year. Ten Lions and three friends of Lions volunteered to make 250 calls. This resulted in more boxes being sold and our customers being happy because we reached out to them.

The lifeblood of any sale is attracting new customers. Last year we had 17 new customers. This year we had 30 new customers, eight from Facebook and 22 from "referred by a friend".

In 2019, we sold 180 boxes to 95 customers.

In 2020, we sold 275 boxes to 143 customers.

Twenty-eight Fort Vancouver Lions and friends participated this year to make the project a huge success. This was truly awesome how the club stepped up this year to help promote our sale.

Gross sales \$11,000, netting approximately \$6,260 for the club!

Mike currently is semi-retired and volunteering at FISH. He'd like to be employed again if the right job came along. He likes to listen to the fire/police scanners as he was once a 911 Dispatcher, would enjoy getting back into hunting if he had a partner, collects playing cards and likes to ride his bicycle.

Diane likes to cook, sew (she has made over 220 masks for friends, family and organizations such as WA Council of the Blind and Edmonds Food Bank), and read (she will be looking for a book club than enjoys a glass of wine as much as a good book).

Both of our adult children, Amanda (29) and Bob (26) are currently living with us. The economy being what it is has made it quite challenging for either of them to find employment.

We look forward to being more involved with the Fort Vancouver Lions Club.

The meeting was called to order by Queen Lion Gay Enyeart at 10:15 AM.

Standard Reports to the Board:

Secretary's Report: A motion was made by Rick Giles, seconded by Allen Rhyasen and approved to accept the minutes from the July 17 meeting.

Treasurer's report: Rick Giles reported on the Administrative and Foundation reports for this month. After the budget is approved, he will be able to indicate the year to date information versus budget. The Treasurer's report will stand as presented pending the audit.

Old Business

20-21.2 NAMI or Club Rejuvenation Pilot Project Lion Craig Limoges presented as a part of the Membership Committee that they met with Stephanie O'Dell and Mark Mansell. A "test" survey was sent to the 4 committee members. The committee has decided on a survey to be sent out to members. A hard copy will be sent to those not using email. Those using email will receive it via Survey Monkey. The surveys are due by August 28th. Mark Mansell will present as the speaker the first 2 meetings in September. The committee is planning to have a finalized Membership Plan by the end of September.

The Washington Elementary School chair will be Martha Johnson, assisted by Jennifer Denny and Eva Halter. Nancy Brown will chair the Share House project. Environmental Projects will be chaired by Doug Wilson. Adam Hegewald will chair the Walk & Knock project. The Diabetes project of Tour de Cure will be chaired by Craig Limoges. Len Leger will contact Gales Creek Camp for that project, as well as the Children's Cancer Camps. WSSB Track Meet will be chaired by Lori Pulliam and Gay Enyeart will assist her. CC Hearing will be chaired by Rick Giles and Bill will check with Ralph Harding about the CC Sight Committee. There is a question of how the Boy Scouts will be able to meet, so no chair at this time.

After a discussion of how to participate in a School Supply Drive, it was suggested that our club focus on getting school supplies for the students at Washington Elementary School since we already have a connection to that school. Lion Martha is in contact with Elizabeth regarding this project. It was moved by Craig Limoges, seconded by Allen Rhyasen and approved that we table the request for school supplies from the Salvation Army.

She also presented a project involving picking vegetables at the Heritage Farm and delivering those to Food Bank. Lion Craig moved, seconded by Lion Rick that the Board approve these as 2 separate projects. These proposals were both approved.

Lions Council Meeting Tuesday, August 18, 2020

Ryan Morrison called the meeting to order at 6:30pm.

IPZC Debbie Mansell will chair the Zone Meeting on Tuesday, October 20, 2020.

- 1st VDG Marilyn Patterson stated that she is impressed with the G2/G6 clubs. She said that the Zone Chair is the cement that holds the clubs together and keeps them connected to MD19 and LCI. The Zone Chair works for the Zone and the clubs. She had considered being Acting Zone Chair for G2 but realized that the responsibilities conflicted with the 1stVDG responsibilities and that it would take the onus of filling the Zone Chair position out of the zone.
- Camas is running a Fall Flower Fund Raiser. Order on line; flowers shipped directly to the customer. They are doing landscaping at Treasure House and planning a virtual food drive. They did clean-up at Camp Curry.
- Salmon Creek is focusing on new screening processes. They plan to loan 4 screening devices to schools and/or ESD112 and train staff at those facilities to do the screening. They are participating in Give More 24 and encourage more clubs to get involved. They will have their annual wreath sale. The process should be set up on line by September 1st.
- Fort Vancouver has three new members. Their frozen berry sale is online; order by August 26 for pick-up on August 29. They are working to update their Policies and Procedures Manual.
- Longview Pioneer is selling Kettle Korn in the Safeway parking lot on Ocean Highway. La Center had a great fireworks sale season.
- PCC J.D. Nellor reported that Walk and Knock will be a Drive and Drop event. There will be no bag folding due to the need for social distancing. There will be designated drop stops and donors will take their food to a drop spot.
- Sight Committee needs more people. Three of the active members are walking wounded. Applications are not being processed; everything is on hold during the pandemic. Sight Committee received a \$15,000 grant from the Lynch Foundation and a \$10,000 grant from the Price Foundation.
- MD19 Annual Convention will be held November 7th Virtually. HUBB, a local site building company, is setting it up. It will be live on November7th and then the sessions will be available online for 30 days. There will be a fee, not yet determined. There will be an Opening Session, an International Guest, a Keynote Speech, a Memorial Service; it's all in the set-up process.

Clark County Lions Sight Committee Executive Council Meeting August 4, 2020 Zoom Meeting

Attending: Jeff Fish, Bill Lundin, Ralph Harding, David Page, Susan Nellor, invited guest Kay Hust President Jeff Fish called meeting to order at 6:40 p.m.

First order of business, a health check in with David Page, Patient Care Co-Ordinator (PCC). Dave is on the road to recovery, but still on light duty orders. A health check in with Bill Lundin, Vice President. Bill is recovering from surgery, still on light duty orders.

Based on the health status of the PCC, President Jeff asked for a motion to defer August and future decisions on waiting applications. Bill Lundin made that motion to defer actions on incoming sight applications for undetermined length of time, at least one or two months. Susan Nellor, Secretary, seconded the motion. No objections, motion passed.

PCC David will attempt to forward July applications that were already in the system, to the two person review teams. Be on the look out teams, no exact timeline.

Discussion of new PCC. There is one potential candidate to be interviewed. Discussion on offering a salary to a qualified PCC, but there were too many questions on how to manage a paid employee to make a decision. This idea was tabled to a future meeting.

Current/temporary PCC David stated basic qualifications that a candidate should have: Basic computer equipment, with Microsoft office tools, email skills, familiarity with Microsoft Access and ability to manage a Sight Foundation drop box account.

PCC David has already created a data base of approved vouchers from 2018 to January 2020. To solve duplicate application requests and other potential abuse issues.

All members having knowledge of PCC work flow were charged with two tasks: one, estimating how many hours a month are needed to do the PCC job, and two, is there a way to streamline/simplify the PCC work load. All ideas from all trustees are welcomed at September 1, 2020 Zoom meeting.




