**The COVID Effect—Masks**

In March when everything shut down and we were all isolated in our homes, I felt helpless! I really did not like that feeling. I have always tried to part of the solution to problems and I wondered how I could help with a solution during this pandemic while sequestered in my home. The only thing I could think of was to make masks; I know how to sew. I had fabric on hand and some elastic. I started out making 200 masks for my daughter in California who is a nurse and the care facility where she works was running out of masks. I mailed them next day priority mail. I continued that process until I had mailed her 750 masks. I was also making masks for friends, relatives and neighbors as well. I very soon ran out of elastic and started buying fitted sheets and I used the elastic out of them for the masks I was making.

After a few weeks I had no elastic, then my first shipment of elastic came in and I was back in business. To date I have made 1,338 masks and I am still sewing masks. None of the masks were sold they were all part of "paying it forward." Really, serving my community can be as simple as just doing whatever I can to help others.

## Santa Store @ Washington Elementary

Fort Vancouver Lions Club and several community partners are making a difference for Washington Elementary students and their families. For the last 15 years the Fort Vancouver Lions Club has provided a "Santa Store" for the elementary school children. The Club buys gifts all year long to stock the store so the children can shop for the gifts they will give their family members. When the children come to the shop, which is set up in the school, they each get to sit on Santa's knee and have their picture taken. With the help of a Lions Club volunteer the child then picks out gifts for the people on their list. There is no cost to the child. Then Covid-19 happened!

As volunteers we are not allowed in the school. For that matter kids aren't allowed in the schools. This could have been a big problem. However, with some quick thinking and with the help of wonderful community partners the Santa Store will happen! First, we knew we would need to be safe for everyone. No contact with the children, social distancing, masks and gloves will be worn at all times. Temperatures will be taken for each volunteer. We decided to use the Amazon model and fill the orders off site and deliver them back to the school.

Next, we had to relocate the Santa Store. Hillcrest Church in Salmon Creek agreed to let us use their fellowship hall to organize the store and to sort the gifts. Moving all of the Santa Store inventory was the next task. One of the Fort Vancouver Lions volunteered his box truck to transport the boxes of inventory from the school to Hillcrest Church and once the orders were filled transport them back to the school. Then the filled orders would be quarantined for a week before they were handed to the children by school staff.

During the process of making these arrangements, a staff member of Washington Elementary School mentioned that last year some children had missed a lot of school because they were sharing a coat with a sibling and could only attend every other day. The children needed warm coats. The Santa Store now had an expanded mission. We put the need before our Community partners, Hillcrest Church, Greater Clark County Rotary Community Service Committee, Alaska Airlines, and Blue Star Transportation along with many friends. They are all collecting new coats and donating money for new coats for these deserving children. We have 198 coats right now and I know we will get the money to purchase the needed 196 additional coats, so every child will have a new coat.

We wanted to give each family a special gift. After a few inquiries, Clark County Quilters Guild is donating 90 handmade quilts and the Linus Project is donating 200 quilts. So each family will get a warm quilt as well for this winter. Way to go Vancouver! What a blessing it is to be part of the solution to easing the pain of hard times for someone else.

## Who's Who in Fort Vancouver Lions Club

Some people are born to serve others, some are trained and some inherit the desire to help those in need. I guess I came from the "inherit the desire group" acquired through my parents. My mom and dad were a part of the migration society that traveled from Oklahoma pan-handle to California for a better future. Fields in Oklahoma had been over-plowed and left without nutrients for years. The agriculture industry just didn't know about crop rotation or soil preservation. My grandparents on both sides were either cotton or peanut farmers. Their parents had come from Wales and the Cardiff area of Great Britain. Much smaller farming in those years before the turn of the century. Usually just enough to take care of their own family and not the homeland.

My mom and dad met through relatives and dated through letter writing; each traveled west to California around 1930 by train. My mom traveled inside the train as a passenger, my father on the outside as a "non passenger". They finally met in Yuma, AZ for the first time and married there. Destined for California they each got back on the train in the manner they had arrived and continued their destination to San Dimas, California, where they lived for a short time with some Methodist church members until they could rent a home.

Dad was a social guru. He could make friends in a mad dog yard. He learned to be a citrus grower in no time. My mom had taught school before leaving Oklahoma and in time earned a certificate to teach in California, which she did for the next 35 years. They both were active in the community, as mayor and as shipmates in the Community Church. Many parties, meetings and card playing at our house. Lots of Canasta.

If you needed a job, you called my dad, and he always found something for you. He drove from San Dimas to the desert one time to help a friend with a broken down car. It took two days; must have been before AAA or roadside assistant. The friend did give him a bucket of fresh honey. He liked new cars, and as life got easier and television and Hollywood got closer to our town the citrus groves became more valuable.

My dad read to me from the local paper one day...."man named Walt Disney is going to build a theme park about 20 miles from here, with 40 acres of parking. Wow, that's going to make my orange, lemon, grapefruit and avocado groves very valuable". And they were, and he bought a brand new yellow and white Ford Fairlane. Showed me 4 \$100 bills he had taken out of the bank to purchase it.

He and my mom loved to be a part of the city barbecue each year. My dad dug a BBQ pit on our property, lined it with bricks, 4' x 6' wrapped a LOT of beef in butcher paper and burlap and after an all night fire in that pit, he lowered those carefully wrapped bundles onto a piece of sheet metal, placed another piece on a ledge at the top of the ground, covered it with dirt and waited for it to cook. About 18 hours later they dug it up. "Cecil and Avis made the best BBQ beef and sauce in the whole country", people would say. And it was good. Later years he was mayor which I'm sure had something to do with that beef. They helped build all kinds of traditions, organized the city parade on Halloween night, and supported all my school events. They personally put up the wooden Santa's on all the street posts at Christmas time as members of the Chamber of Commerce. He was a Kiwanis member and made sure I could go to summer camp and girls scout camp. I loved camp and all the happiness that occurred during that week.

Yes, my parents worked hard to make sure that I had a happy childhood. They instilled a good work ethic, a sense of service and belonging to a community. Pride and respect were very important to them. Education was the by-word for our household as it is today. Get a good education and you can do anything.

From high school I went to Citrus College at night, worked during the day at the only bank in town, Bank of America. Then I got married. I have 5 children, 3 boys, 2 girls, 16 grandchildren, 14 great grandchildren, and I can safely say my children are great parents and spouses. They are teaching their children good work ethics and to give back to their community. They are busy in many parts of the community including church life.

I think I'm happiest most when I'm serving others. My dear husband is a great support to me in anything I want to do. He never complains if I'm making lanterns late at night, sewing COVID-19 masks, making quilts to give away, or cooking dinners to help those in need.

Lions offers us the opportunity to help others. It's our way of giving back to the community what previously has been given to us.

I hope all Lions are safe and happy this holiday season.

**October 16, 2020 10:30 – 11:30 AM**  
**Via Zoom in the time of COVID-19**

Queen Lion Gay called the meeting to order at 10:30 A.M.

**Board Members Present:** Queen Lion Gay, Bill Shalaby, Allen Rhyasen, Rick Giles, Martha Johnson, Doug Wilson, Helen Sutfin, Eva Halter, Craig Limoges and Shelly Brown. A quorum was present.

**Standard Reports to the Board:**

**Secretary's Report:** A motion was made by Rick Giles, seconded by Eva Halter and approved to accept the minutes as presented from the September 18<sup>th</sup> Board meeting.

**Treasurer's Report:** Rick Giles presented the Treasurer's Report he had sent out. There were no questions. He had 3 items to discuss with the Board. 1. PayPal is being difficult with closing the account connected to Steve Staudinger's information. A new account has been set up and Dotty has the information to put on the website. 2. During reconciliation of the accounts, there are 3 outstanding transactions from Heathen Brewing. Rick will reverse those transactions, since the money was never drawn out of the account. 3. There were 3 Lions who paid their dues last June, and the money was incorrectly deposited in the Foundation account. It will be moved into the Administrative account and will show on the November Treasurer's Report.

**Old Business:**

**20-21.2 Update Club Rejuvenation Pilot Project** Lion Craig Limoges presented on the progress of this project. After completing the survey, the next step will be for Craig to create a Membership Plan. The Committee will continue working on this plan and then send it to the Board when it is ready.

**20-21.3 Club Policies and Procedures** Craig Limoges has made a few changes to the Policies and Procedures Manual. There will need to be a few more changes to update the wording about one PayPal account. These will be sent out by email to be approved by the Board Members.

**20.21.9 Postal Permit** Gay Enyeart discussed the Postal Permit, indicating that it had expired May of 2020. After 2 years, that account may be closed by the USPS. The cost of the postal permit is \$240 annually, which goes up with a postal rate increase. This account has been flagged to not be closed. Craig moved that we do not pay for the bulk permit until such time as it is decided that it is worth it. Seconded by Rick Giles. After discussion, the motion was passed.

**New Business:**

**Service Projects–Bill Shalaby**

Washington State School for the Blind cancelled the Track Meet for May 2021.

Pacific University has a new screening van. They are working with the Sight Committee. Rick moved to table FVLC involvement in the Pacific University screening van. Craig seconded the motion and it was approved.

Craig shared about the service project cleaning up a yard in Vancouver on Saturday. There are 8 people signed up.

Doug Wilson shared that he is looking for environmental projects for the club. He sent out information about a tree planting activity for Oct. 24.

Martha Johnson reported that students do not need school supplies. They have been supplied with computers provided by the school. Teachers are teaching from their classrooms.

Martha suggested doing a Peanut Butter Parade to be taken to the Food Bank. She will coordinate with them.

Martha shared that we are unable to participate in the Thanksgiving meal for the students.

**20.21.10 Santa Store** – Eva Halter shared that the Santa Store will work similar to an Amazon store. Students will give family member identifiers and then the gifts will be put into donated paper bags along with wrapping paper and scotch tape. All COVID-19 protections will be taken. Rick requested the committee should check with the Board for purchases over \$2,300.

**20.21.11 New Member Approval** Rick Giles made the motion to approve Katey Newland as our newest club member, seconded by Martha Johnson. The Board passed the motion.

**Anything for the Good of the Order**

Board Retreat date is October 24 from 9:00 AM until Noon at Gay's church. She will send out the address and agenda.

Lion Rick Giles asked the Board about an uncashed check to the Sight Committee for a memorial contribution. The Board recommended that he reissue the check.

Lion Helen Sutfin recommended that all Board members sign up for the MD-19 Virtual Convention on Nov. 7. Meeting was adjourned at 11:33 AM

## Lions Sight Committee of Clark County Zoom Minutes November 3, 2020

**Attending:** Jeff Fish, Bill Lundin, David Page, Ralph Harding, Harry Barratt, Mike McCamish, Al Kostman, Stephanie O'Dell, Casey O'Dell, and Susan Nellor.

Meeting called to order at 6:30 by Jeff Fish.

**Approval of October minutes:** Jeff asked for a motion to accept the minutes as written. David Page made that motion, seconded by Al Kostman. Voted on and motion passed.

**Treasurers report:** Ralph Harding announced donations of \$1,000 from Vancouver Lions and \$4,370 from Salmon Creek Lions. \$1,212 of vouchers were paid out. 21 vouchers are pending. Checking account balance is \$10,605. Endowments balance is \$64,926. Jeff Fish asked for a motion to accept Treasurers report as presented. David Page made that motion, Harry Barratt made the second. Voted on and approved.

**Old Business:** Discussion on residency requirement on Sight applications was tabled. Pacific University Screening Event rescheduled to December 10, 2020. The MOU has not been signed, yet. The Sight Committee is having difficulty finding qualified clients meeting the vision/medical insurance terms of Pacific University. We are moving forward with Jeff and Ralph volunteering to staff the event. David is continuing to find clients. Bill Lundin suggested contacting Homeless shelters and reaching out to Dr. Clausen of the Low Vision Clinic to find potential clients. There is a time deadline for completion of COVID-19 attestation form.

**New Business:** It is time to update the LSFOCC website. Discussion of need to add a "donate" button and to add more information on how to contact the Foundation. Jeff asked for a motion to allow David Page to spend up to \$250.00 to have Dotty Scott make these improvements.

Susan Nellor made the motion, Ralph Harding made the second. During discussion of said motion, the amount was increased to \$300.00. Motion was voted on and approved. (see attached email from Dotty Scott)

David Page submitted his resignation as Patient Care Coordinator. There was a discussion on how to proceed: should we find a paid "employee" to learn the job? Should we reach out to our sister organization in Cowlitz County led by Hope Ramsdale to learn their method of doing business? Should we review client vouchers by smaller committees similar to the method that we are currently using to review applications, with an emphasis on making volunteers feel necessary, useful, and appreciated; no rubber stamping. Bill Lundin pointed out that the PCC's responsibilities is a very hands on job including keeping our providers happy with doing business with us for example knowledge is required of which offices take Medicare patients and how many. The assigning of clients to partners is very time consuming. It will be very difficult to break apart the procedures of the PCC job to spread among teams. The concerns that were brought up: a backlog of vouchers, wait time for patients will increase, learning the Social Service agencies and making sure that our partner clinics do not feel overloaded with low fee patients. Another discussion was had on changing the timeline of when to distribute vouchers to providers. Should we not wait for a once a month "dump" on providers but distribute on a more timely basis. There was a lot of discussion of the PCC situation, but no solution was found. It is undeniable that the future of the Lions Sight Foundation of Clark County is at stake.

Meeting was adjourned at 8:05.

## Duties Of Club Positions

### Club President

He/she is the Chief Executive Officer of the club and chairs all regular and board meetings. With the assistance of the Board of Directors, appoints committees. The Club President is an active, voting member of the Zone Advisory Committee in which his/her club is located. The Club President should be familiar with standard parliamentary procedures and be able to conduct a meeting according to these procedures. The Club President is the leader who inspires and motivates.

### Immediate Past President

Assists the President in any way possible without infringing on the position of President. He/she should be available to offer advice and support to the President when asked. The Immediate Past President is also in charge of club administration--the running of the club itself. Areas under this responsibility include membership, banquets, luncheon programs, the club newsletter, visitations to other clubs, and the supplies and equipment required for each membership meeting. The Immediate Past President ensures that duties are assigned to members so that his/her areas of responsibility are accomplished. He/she is a President in Training who is available to step in to conduct a meeting if the President is unable to perform this duty.

**Vice President(s):** While our club has two Vice-Presidents with their respective areas of responsibility, these VPs are fortunate to have a number of project chairmen with direct responsibility for specific projects.

The **1st Vice President** watches over the fundraising activities of the club. This VP has the responsibility for ensuring that recurring fundraising projects have a project chair and the projects are successful. Again, our club is fortunate to have a number of members who step forward as project chairs of specific fund-raising activities. The 1st VP also helps identify and evaluate new fundraising projects.

The **2nd Vice President** oversees service projects. This VP is tasked with ensuring that recurring service projects have a project chair and the projects are successful. He/she also has a number of club members who serve as service project chairmen. He/she helps identify new service opportunities that match the ability of our club to serve.

### Secretary

The Secretary keeps all records pertaining to the operation of the club and the status of the members. He/She submits required membership and activities reports to MD19, Lions Clubs International, the District Governor, Vice District Governor, and Zone Chair. The Secretary is responsible for all club correspondence and should act on instructions from the Board of Directors. The Secretary is responsible (unless a Lion has been appointed to this task) for ordering all club supplies. The Secretary or Treasurer is responsible for issuing statements to members for dues and any other items due the club. The Club Secretary, together with the club President, is an active, voting member of the Zone Advisory Committee.

### Treasurer

The Treasurer is the banker for the club and is responsible for the distribution of any funds within the club. He/she is required to set up accounts as directed by the Board of Directors and to insure regular financial reports are available to the Board of Directors and members of the club. At the direction of the Board of Directors, the Treasurer pays all bills. The Treasurer shall insure that any checks issued by the club are properly recorded. He/she may be asked to collect the money for meals at each meeting.

### Lion Tamer

The Lion Tamer is the caretaker of the club's paraphernalia and is responsible for having all equipment in place before the meeting starts. In some clubs the Lion Tamer is responsible to greet guests and supply a list of these visitors to the President before the meeting starts so they can be introduced properly.

### Tail Twister

The Tail Twister creates fun at the regular club by playing pranks, imposing fines (in good taste) for various reasons and running contests. The funds raised can be used for any administration purpose the club decides.


### Directors

Our club has four directors. They assist the President in the formation of the policies and procedures of the club and ensure that these are followed. Directors shall also oversee the various committees of the club and ensure reports are submitted to the club on the status and progress of such committees. The Directors vote on issues brought to the Board for a vote.

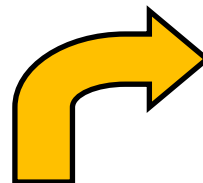
