Who's Who in Fort Vancouver Lions Club



Fort Vancouver Lions Club and Foundation Board Meeting Friday, March 19, 2021 10:00 A.M. Via Zoom in the time of COVID-19

Oueen Lion Gay called the meeting to order at 10:00 AM

Board Members Present: Queen Lion Gay, Craig Limoges, Rick Giles, Bill Shalaby, Allen Rhyasen, Eva Halter, Helen Sutfin, Shelly Brown and Jennifer Denny. A quorum was present.

Standard Reports to the Board:

Secretary's Report: A motion was made by Lion Allen, seconded by Lion Craig and approved to accept the minutes from the February 19, 2021 Board meeting.

Treasurers Report: Lion Rick shared the status of the Administration and Foundation accounts. There are some checks to be deposited soon. Rick completes the monthly information at the end of the month, which is 3 weeks before the Board Meeting. The Treasurer's report will stand pending observation.

Observation Committee Report: The observation committee is Gay Enyeart, Bill Shalaby, Allen Rhyasen. The observation report (2019-2020) indicated that the current club laptop doesn't have the capacity to run the necessary software. The current Treasurer is using his personal laptop to perform his duties. The observation committee has recommended that the club purchase a laptop capable of performing the current and future needs of QuickBooks, which will need to be purchased as well.

Procedures for checks over \$500 are not in compliance with the club policies and procedures. Two signatures are required for checks over \$500.

A new PayPal account was opened in order to close the account associated with Lion Steve Staudinger's name. PayPal statements are not able to be verified, since the previous account was closed. The committee recommends that the new statements be printed each month and be filed with monthly the activity.

These observations should be done on a yearly basis between July-August.

OLD BUSINESS

20.21.17 LCI Proposed Dues Increase Lion Rick recently sent out a chart with all of the current membership types available through LCI. Currently our club only has 3 categories of membership dues options. Lion Rick wants to have all of the options that LCI has available. At this time, there will be no increase to the dues to members. A motion was made by Lion Craig to add these additional categories, seconded by Lion Eva and approved by the Board.

20.21.19 Shred Day Lion Allen provided an update on the upcoming Shred Day event. The event is scheduled for May 22 at the United Methodist Church on Mill Plain. He stressed the need to make sure that this event is well publicized. At the current time, there are 4 corporate sponsors. The banner will be printed for a price of \$180. The vinyl signs will be printed for \$20 each. Lion Allen is looking to locate construction cones for this event. He is looking to have about 10-12 volunteers with this event. Lion Eva suggested we hand out a small brochure detailing our upcoming event.

20.21.20 Food Drive Lion Craig reported on the Food Drive from last weekend. A summary was sent to the board. A total of 805 pounds of donations were made from this event. Much was learned from this to help with the next time we will have this event. There was a nice write-up in the Columbian afterwards.

District 19G Spring Conference: Lion Helen reminded the Board about the upcoming conference May 7-8. Friday's event will be a virtual experience and Saturday will be an in-person event with a picnic where the Global Showcase will be presented. This event is completely free, all you need to do is register. Pioneer Lions is hosting this event.

International Conference: The information about the International Conference has gone out. Register before March 31 for the \$50 fee. After April 1, the fee is \$75. The International Conference is scheduled for June 25-29 as a virtual event.

NEW BUSINESS

Presidents Council Meeting: Lion Allen reported that the premise of this month's meeting was to look at ways that clubs can help other clubs with ideas and activities. The upcoming meeting on April 20 will be an opportunity for the next Board Members to participate.

Service Projects Lion Bill shared his thanks to Lions Craig & Mike for organizing such a successful Food Drive event. **Commitment to NEW Service Project Challenge 2020-21 District 19-G**: Our club has participated in this challenge. Lion Gay will be completing this paperwork to submit to the District.

Wastebusters: Lion Craig shared that 8 of our club members are participating in this activity. We are doing very well in our challenge against the Camas Lion Club.

Membership Committee: Lion Craig reminded the board about the Maui contest by DG Doug Harvey. All members who have sponsored a new member during the 2020-2021 Lions year are eligible for the drawing.

For members of the Fort Vancouver Lions Club, Lion Rick is offering a sailing adventure to a sponsor of a new member for the 2020-2021 Lion year. The details will be coordinated between Lion Rick and the winner!

New Computer Research: Based on the Observation Committee's recommendation for the club to purchase a new laptop that is capable of running the software necessary to keep the books, Lion Rick presented a recommendation of a computer to purchase through Costco. A motion was made by Lion Eva, seconded by Lion Jennifer that we make a purchase not to exceed \$1,120.00 for the hardware and software needed. The motion was approved to make this purchase.

Lions Sight Foundation of Clark County ZOOM Minutes April 6th, 2021

Attending: Jeff Fish, Bill Lundin, Ralph Harding, David Page, JD Nellor, Michael McCamish, Stephanie O'Dell, and Susan Nellor.

Meeting called to order at 6:35 by Jeff Fish.

Approval of March minutes: Jeff Fish asked for a motion to approve the minutes as presented. Motion made by David Page, seconded by Bill Lundin. The minutes were approved as presented.

Treasurers Report: the March ending checking account balance was \$7,589.00. Donations were as follows: Salmon Creek made two donations of \$2,197.00 and \$1,500.00. David Page in the amount of \$500.00. The grand total of all donations was \$4,979.00. The new checking account balance is \$11,786.00.

The disbursements include 26 vouchers, \$3,085.00, printing costs for envelopes and voucher paperwork, \$297.00 and the annual Officers and Directors Liability Insurance payment thru Old Republic Security Group (in the amount of \$75,000) for \$149.00. This was a grant total of \$3,531.00.

After reporting a gain of \$71.00 the endowment is at \$65,470. Including the checking account total of \$11,786.00 the Sight Foundation has an on hand cash total of \$77,256.00.

Jeff asked for a motion to approve the Treasurers report. David Page made the motion, seconded by Susan Nellor. Treasurers report was approved as presented. Ralph Harding reported that Year to Date donations from the Clark County Lions Clubs total \$16,592.

Old Business: The Pacific University Eye Screening event will be managed by Jeff Fish and Ralph Harding. Ralph Harding will make a follow-up visit to Stanton Optical to confirm the details of their potential partnership with the Sight Foundation. Jeff Fish is continuing to work with America's Best on a similar partnership and David Page is going to touch base with Lens Crafters (at Westfield Mall).

The search for a Patient Care Coordinator is still ongoing. Jeff Fish is going to widen the search by contacting our partner eyeglass providers for the names of any individuals with a community service interest to fill the PCC position. Ralph is continuing to work on a PCC job description.

The sale of the Marshall Tucker guitar is still a work in progress.

Thank you to Stephanie O'Dell for submitting the Focus Grant paperwork to Southwest Washington Community Foundation.

New Business: Jeff Fish will send a reporting letter to Price Foundation by June, 2021to showcase the use of their donation. This ends our reporting obligation.

Susan Nellor reported that the Thank You card project to all our Optician partners was accomplished.

The 2020-2021 year is coming to an end on June 30th. There was a first discussion of officers for the 2021-2022 year: President Jeff Fish (continuation), Vice-President Bill Lundin (continuation), Ralph Harding, Treasurer (continuation) Secretary, Susan Nellor (continuation), and PCC Ralph Harding (continuation). This discussion will be tabled until the May meeting.

A lively discussion was held concerning the addition of an equity policy statement and a non-discrimination policy statement to be added to the Standing Policies, Procedures and Rules of the Lions Sight Foundation of Clark County. Stephanie O'Dell researched these topics and presented her findings as well as presenting a first draft of each of these statements. Stephanie is taking many suggestions under consideration and is continuing to work on revised statements. A suggestion was made to have Jeff Fish make an announcement at the next President's Council on April 20 for more Lions to participate in the finalization of these policy statements. JD Nellor volunteered to contact LCI legal and MD19 about these two issues.

Patient Care Coordinator report: 18 applications were reviewed. 17 approved, 1 denied (too soon). Eight of these 17 applicants will be at the April 7th Pacific University screening event. Nine will be sent to partner clinics.

Stephanie O'Dell brought up the idea of testimonial videos made by grateful recipients of eye exams and eyeglasses. She presented a poem written by a grateful recipient. Jeff Fish and Stephanie are researching partners to help create these videos.

Meeting adjourned 8:06.

19G2 ZOOM ZONE MEETING APRIL 20, 2021

PZC Helen Sutfin called the meeting to order at 6:30pm. Salmon Creek President Jack Johnson led the Flag Salute.

Clubs present: Salmon Creek, Cascadia, Vancouver Dawn, La Center, Fort Vancouver, Hazel Dell, North Clark, Camas.

Summaries of club Lion year during the pandemic:

- Salmon Creek partnered with the Watershed Project to clean a community park. They continued to lend their vision screening equipment and teach borrowers how to use it. They are selling hanging baskets and patio planters of spring/summer flowers. They are processing their membership surveys. The proceeds from their upcoming shred event will go to the Free Clinic. They are planning an Orientation Session, will participate in Give More 24 in September, and are looking into recycling Styrofoam. They have one reinstated member.
- Cascadia Lions are planning a Bike Rodeo in June. They are making individual graduation cards for all 700+ of Cascadia Techs graduating seniors.
- PZC Helen offered the Zone's condolences to Vancouver Dawn on the loss of their long-time member, PDG Bill Karcher. Vancouver Dawn is having its first real meeting tomorrow. The Crystal Plum Bazaar is on schedule for Saturday, November 13, 2021. The current officers will stay on.
- La Center contributed funds to help an injured tow truck driver. They contributed funds to the police department to buy stuffed animals to give to kids who needed comforting. They cleaned the post office lot.
- Fort Vancouver has been meeting weekly on Zoom. A club survey showed that members are not comfortable with the idea of in-person meetings. They held a one day drive through food drive and collected 800 pounds of food for the food bank. They have been preparing lunch at Share House on the third Wednesday of each month since November. They have a Shred Event on May 22nd, proceeds to go to Clark County Lions Sight and Hearing. Eva Halter was elected Zone Chair for the 2021-2022 Lion Year; Gay Enyeart was elected Associate Zone Chair. They have one new member. New officers for next year have been elected.
- Hazel Dell is doing lots of service but it is mostly individual: assistance for the 6-8 Food Pantry, blood and platelet donations; Green Bags, WinCo food gift cards and cleaning and hygiene supplies to the Community Outreach Center at Hazel Dell Elementary School.
- North Clark has been cutting firewood to donate to people who need it for heat. They held elections.
- Camas has elected next year's officers. They did clean-up at Camp Currie following winter storm damage. They did clean-up in downtown Camas. They have a shred event scheduled for May 8th. They are calling all members to check on how they are doing.
- ◆ Lions Jeff Fish and Stephanie O'Dell gave a presentation on the Clark County Lions Sight Committee. They emphasized the need for representatives of each club to participate in meetings and for each club to donate to the committee. The committee has applied for and been granted from several local charitable trusts. They shared a letter of appreciation from a person who received glasses from the Sight Committee. They will forward the letter to all clubs to be used as a testimonial when promoting the CCLS Committee. There is also a testimonial video. Sight Committee meets on line. Requests for assistance are down from 48-50 applications per month to 18-20 per month. Sight Committee has begun working with major suppliers like Stanton Optical in addition to local optometrists. A Patient Care Coordinator is needed. The Patient Care Coordinator is responsible for contacting the applicant to make the arrangements for the exam and glasses and for deciding which optometrist the person will see. A detailed job description for the Patient Care Coordinator is being worked on.
- ♦ Fort Vancouver member Cheri Perry nominated Gay Enyeart and Eva Halter for co-Zone Chairs for the 2021-2022 Lion year. Question was raised: if two people are being nominated shouldn't there be two separate nominations? Fort Vancouver member John Lyon nominated Eva Halter for Zone Chair. Shelly Brown seconded. Motion passed. Jack Johnson, Salmon Creek, nominated Eva Halter for Associate Zone Chair for the 2021-2022 Lion year. Shelly Brown seconded. Motion passed.
- ♦ PDG Steve Patterson gave a brief history of CARE. The current CARE project is to build schools and provide education for girls 9-19 in Haiti. 19G leads the Multiple District in donations to CARE. For a \$500.00 donation to CARE a club can present a Gordon Smith Fellowship as recognition to someone. PZC Helen recommended PDG Steve as a meeting speaker.
- ♦ 2nd VDG Debbie Mansell said Leader Dogs was founded 82 years ago by three Lions. Lions contribute 20% of the cost of providing leader dogs. A leader dog and the 21 days of training for the blind or visually impaired person with the dog are free to the recipient. Overall cost per dog from birth through training and follow-up after placement is \$45,000. Contact Leader Dogs for a speaker for a Zoom meeting.

- ♦ There are three clubs in 19G2 that have reached Model Club status (\$500.00 per member to Campaign 100): Salmon Creek, Vancouver Dawn, and La Center. The Tel-A-Thon raised \$750.00 to date with some funds still coming in; they are hoping to reach \$1,000,000. PDG Mark Mansell reported that due to the pandemic Campaign 100 has extended to June 30, 2022.
- ♦ Global Service Coordinator Brian Wolfe has received Service Challenge information from Battle Ground, Salmon Creek, and Fort Vancouver.

PDG Steve Staudinger reminded everyone to bring the numbered Lion pin from the burlap G bag to the Saturday in-person part of the district conference. He will be drawing for the two \$500 and one \$250 winners.




